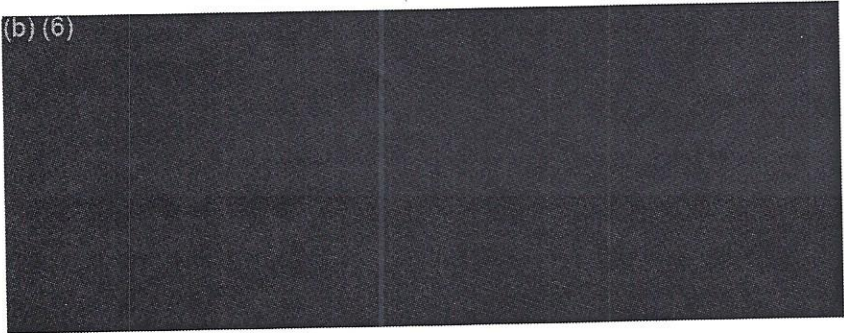

Hi Don,

I got a call from Nick Alidoosti. He is a businessman in Canada and had heard about our issues on Vermont Public Radio. After I explained the difference between the sale eligible animals and the adoptable animals, I told him that by law, we had 10,000 sale eligible horses that could be shipped to Canada and 20,000 animals that could not be sold, but could be euthanized.

I told him that if a decision was made to euthanize horses, there would probably be a contract that would solicit bids. He wondered if the winner of the contract could do what he wanted with the carcass - ie., euthanize the animals in a way that would allow the meat to be sold for human consumption. I told him I didn't know if that would be possible. We then discussed the sale eligible animals.

His idea was to sell the meat of the 10,000 horses to other countries and then give the profits back to the BLM to pay to keep the other horses in holding. (Sacrifice some of the animals so the others can live.)

If something like this was to happen, we would need to remove the following wording from the bill of sale:

Purchaser agrees not to knowingly sell or transfer ownership of any listed wild horse(s) and/or burro(s) to any person or organization with an intention to resell, trade, or give away the animal(s) for processing into commercial products.

I sent him information on the cost of shipping a load of horses to Canada the cost of caring for 10,000 horses for the rest of their lives on long term holding. I am waiting to hear back from Alidoosti to see if he is still interested and if so, how soon he would be ready to receive horses.

I don't know if Alidoosti will follow through, but I think we need to be ready to sell if the opportunity presents itself. Please let me know if you have any questions. Thanks, Sally

After Henri announced at the Advisory Board Meeting that we would have to follow the law. I received an e-mail from a guy in Canada who thought if the older sale eligible animals were sold to feed the hungry in third world countries for enough \$, then the remaining horses in holding would be able to stay in holding because of this \$. Sacrifice a few to save the majority. I called him to find out his plan and told him that I would share his idea. After our initial conversation I never heard back from him.

Oregon has adopted horses to a trainer who trains the animals and once titled sends them to Denmark as riding horses. If younger sale eligible horses could be found, more animals would find good homes in Denmark.

We received a FOIA for all notes having to do with the plan that Lili and others drafted in case we got the go ahead to follow the law. I think that is where this information came from.

I also shared ideas I received that included harnessing the horses in the wild to a pulley system and having them run up and down mountains to generate electricity.
